RE: FREEDOM OF INFORMATION REQUEST

I write in response to your Freedom of Information request received by the University of Sheffield dated 20 October 2014 requesting information on higher paid staff.

Please see the tables given in the Appendix to this request in answer to your questions. Names have been removed and some job titles have been redacted to prevent identification of individuals.

Information relating to living individuals is personal data as defined in the Data Protection Act 1998. This data is therefore exempt from disclosure under S.40 of the Freedom of Information Act 2000 (Personal Information). This is an absolute exemption and is therefore not subject to the Public Interest Test.

All the staff listed are either clinical academics or senior managers. Pro-Vice-Chancellors are academic staff who serve in a senior managerial capacity. The University does not have a system of tenure.

This information should be read in conjunction with the information on remuneration, including that of the Vice-Chancellor, published in the University's Financial Statements at www.sheffield.ac.uk/finance/finstatements

The remuneration for previous years listed in the Appendix refers to the individuals that received remuneration of more than £150,000 in 2013–14, not to the posts that they currently occupy, so there will be no data where individuals have joined the University within the last five years and the remuneration lists may have been earned in roles other than the job title listed.

Your complaint will then be subject to an internal review.
